

Total Installed Capacity (MW)







Outstanding Agriculture and Tourism Companies in Turkey


Aksa Agriculture manufactures beef & dairy products in conformity with the EU standards on 25.000 decare of land and performs arboricultural activities.

Aksa Agriculture manufactures beef & dairy products in conformity with the EU standards on 25.000 decare of land, held on a 30 year term lease from the former state owned enterprises Inanlı (Tekirdağ) and Gelemen (Samsun) Agricultural Farm, which were privatized in 2004.

Alongside this, Aksa Agriculture produces outdoor ornamental plants, shrubs and rootstocks in fully automated greenhouses and tissue culture laboratories. On Inanli Agricultural Farm, drip irrigation method is used to produce two crops annually and to irrigate 20,000 grafted walnuts in nursery. On Gelemen Agricultural Farm, EU Standard grown 270.000 apple saplings of our own certified production have been planted on 1.000 decare of land.



Our safe modern and technologically advanced systems employed in our dairy operations use a fully computer-integrated bar coding system to monitor a dairy herd of 2.000 heads of cattle. In the forthcoming year we aim to fulfill our countries needs for high genetic quality stock heifers.







These establishments ensuring maximum levels of hygiene have become a model in agriculture and husbandry for Turkey.












MIRADA DEL MAR


